- Rental payouts are now in USDT for all products. Whenever you rent out a product (e.g., office, shop, land/building shares, vehicles when live), your rental income is settled in USDT.
- Secondary-market resales are settled in USDT.If you resell a product on the marketplace, your sale proceeds are paid in USDT.

What remains the same

- Primary purchases on the Veelive marketplace use XON.You acquire products with XON on the primary market.*(Existing exceptions continue to apply—e.g., Influencer Nodes, character purchases/upgrades use USDT.)*

Quick reference

- Buy (primary): XON
- Rent out (income): USDT
- Resell (secondary): USDT

Why this change

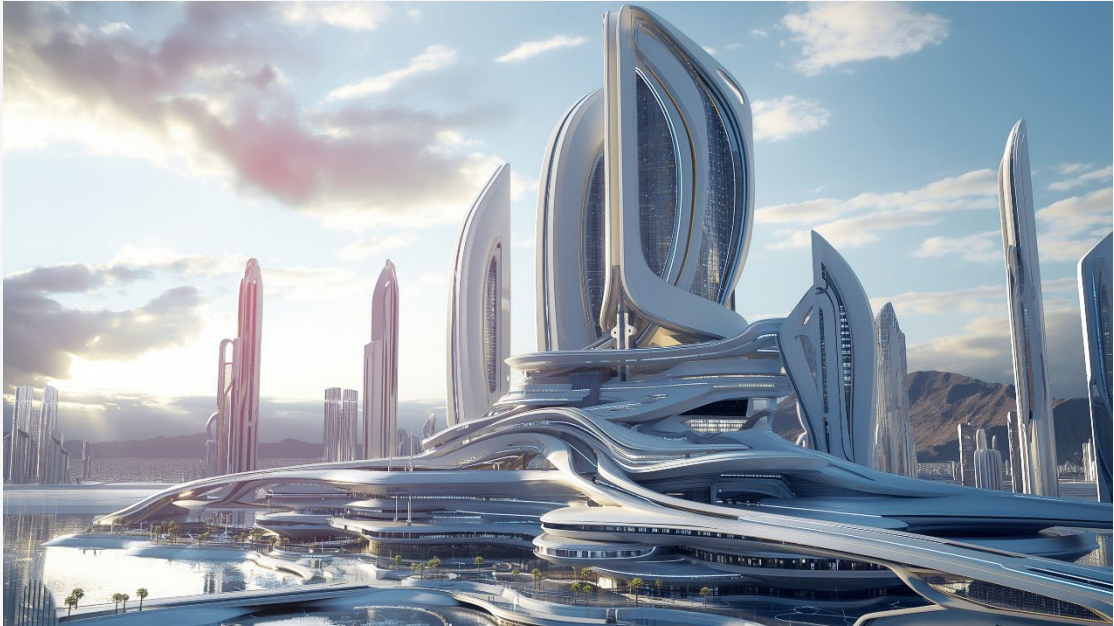
- Clarity & liquidity: Creators and owners receive earnings in a widely used stable unit (USDT).

## Veelive Ecosystem – XON Token

Note: This is a focused excerpt on the XON token and its use in the Veelive ecosystem. Language has been simplified for clarity. All examples are for illustrative purposes only and do not constitute a guarantee of returns or prices.

### 1) Summary

XON is a pure investment/utility token within the Veelive ecosystem. With XON, users acquire product-oriented assets (e.g., land/building shares starting at 1 m<sup>2</sup>, shops, offices; later vehicles/ships/aircraft) and can thus generate rental income in USDT or resell products (USDT proceeds). USDT is mandatory for selected products (e.g., characters, upgrades, influencer nodes).

A key instrument is the Startfund: it allows users to obtain XON at a significant discount against USDT for a limited period of time in order to participate in the ecosystem more quickly.

### 2) Roles & Products (Overview)

- Products that can be paid for with XON:
  - Land/building shares (from 1 m<sup>2</sup>)
  - Shops & offices (virtual commercial space)
  - (Planned) Vehicles, yachts/ships, aircraft, etc.
- Products paid for exclusively with USDT:
  - Characters
  - Upgrades
  - Influencer nodes

### 3) XON – Purpose & Use

- Investment token in the ecosystem: Acquisition of Veelive assets (see above).
- Earnings logic:
  - XON fixed credit (see § 5A) for certain tangible assets (e.g., land/construction) – credit in XON, reinvestable.
  - USDT cash flows (see § 5B) from leasing/resale depending on the product in USDT.

- No payment substitution outside the ecosystem: XON is designed for internal product economics.

#### 4) Startfund – Mechanics & Example

Purpose: Users should be able to purchase products at a lower price in the early stages by exchanging USDT → XON at a discounted rate.

Core rules: - Time window: The Startfund can be used for a maximum of 6 months (per user/character context). - Conversion rate: In the Startfund, the rate is typically between 7% and 6% or 5% (depending on character level and phase). "The higher the character, the cheaper." - Cap/limit: For the first character, the Startfund volume is limited to 4,000 USDT Target XON (additional caps per character possible). - Exception products: Characters, upgrades, influencer nodes not via Startfund/XON, only USDT.

Example 1 (first character setup): - Target: 1,000 USDT equivalent in XON - Startfund rate (first level): 7%

→ USDT payment =  $1,000 \times 0.07 = 70$  USDT → XON credit = 1,000 XON (as purchasing power for XON-eligible products) - Cap: For a target XON of 4,000 USDT, the payment would be a maximum of 280 USDT ( $4,000 \times 7\%$ ).

The rate may decrease to 5% depending on character level. Allocation and gradations will be announced in the Startfund plan.

#### 5) Returns & Cash Flows

##### A) XON fixed credit (reinvest in products)

- For certain assets (e.g., land/building shares starting at 1 m<sup>2</sup>), the user is credited with a fixed amount in XON on a monthly basis.
- Purpose: Reinvestment in other XON-eligible products and portfolio development.
- Note: The amount, term, and conditions of the fixed credit are based on the applicable product/return plan and may vary depending on the project.

##### B) USDT income (rental & resale)

- Rental: Shops/offices and, in the future, vehicles/ships/aircraft can be rented out. The rent is paid out in USDT.
- Resale: Products can be sold later, with the proceeds of the sale being paid in USDT.
- Operational processing: Rental periods (e.g., 6 or 12 months), billing modalities, fees, and availability are shown in the product dashboard.



## 6) Exchange function (XON ↔ USDT peer market)

An integrated exchange marketplace allows users to offer XON holdings and set their desired USDT proceeds themselves (order book principle). Supply and demand determine the price.

Process: 1. User enters XON amount and desired price in USDT. 2. Offer appears in the order book; other users can buy in full or in part. 3. Upon execution, the seller receives USDT and the buyer receives XON. 4. An exchange fee may apply (see fee schedule).

Example 2 (price formation): - Purchase via Startfund: 1,000 XON (target value) for 70 USDT (7%). - Later offer on the exchange market: 1,000 XON for 80 USDT.

→ Upon execution, there is a gross difference profit of 10 USDT (plus/minus any fees).

Important note: Success and execution depend on demand from other users. There is no guarantee of sale.

## 7) Why the system works (incentives & limits)

- Starting fund limit per character: Each user has a starting fund limit per character. This keeps access to XON at a low price.
- Character progression: Higher character levels grant better starting fund rates (e.g., up to 5%) and/or higher caps—increasing the incentive to remain active in the ecosystem.
- Time scarcity: The starting fund can be used for a maximum of 6 months. Anyone who needs additional XON later can either use USDT purchases or the exchange market.
- Reinvestment loop: XON fixed credits (for eligible assets) + USDT rentals increase the ability to act (further purchases, rentals, resales).

- Market price risk: XON prices on the exchange market are volatile and are determined by supply and demand.

- USDT: Stablecoin settlement currency for rents/sales proceeds and for USDT-mandatory products (characters, upgrades, influencer nodes).
- Exchange function: Integrated peer market for selling/buying XON against USDT.

## Appendix A – Formulas (informative)

- USDT payment (starting fund):  
 $\text{USDT\_paid} = r \times \text{XON\_target\_value}$  (with  $r \in [0.05; 0.06; 0.07]$  depending on level)
- Example:  $\text{XON\_target\_value} = 1,000, r = 0.07 \Rightarrow \text{USDT\_paid} = 70$ .

As a result, it offers almost the same features as Simplicity and Solidity, while approaching the development of smart contracts through the use of purely mathematical functions in the code.

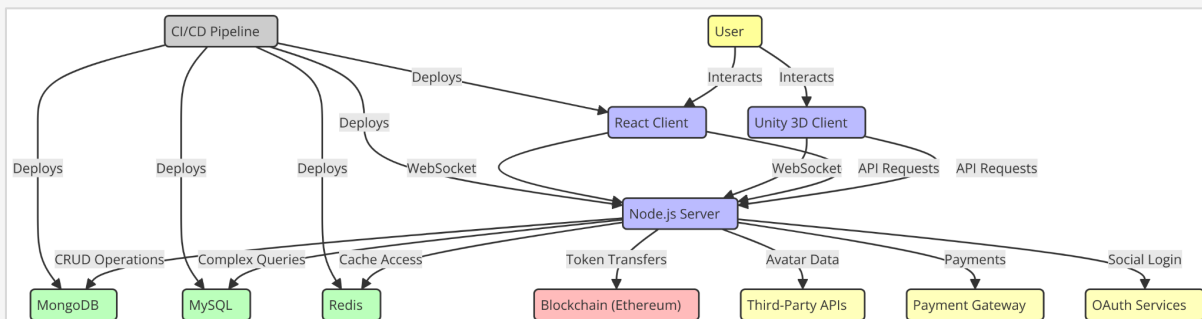

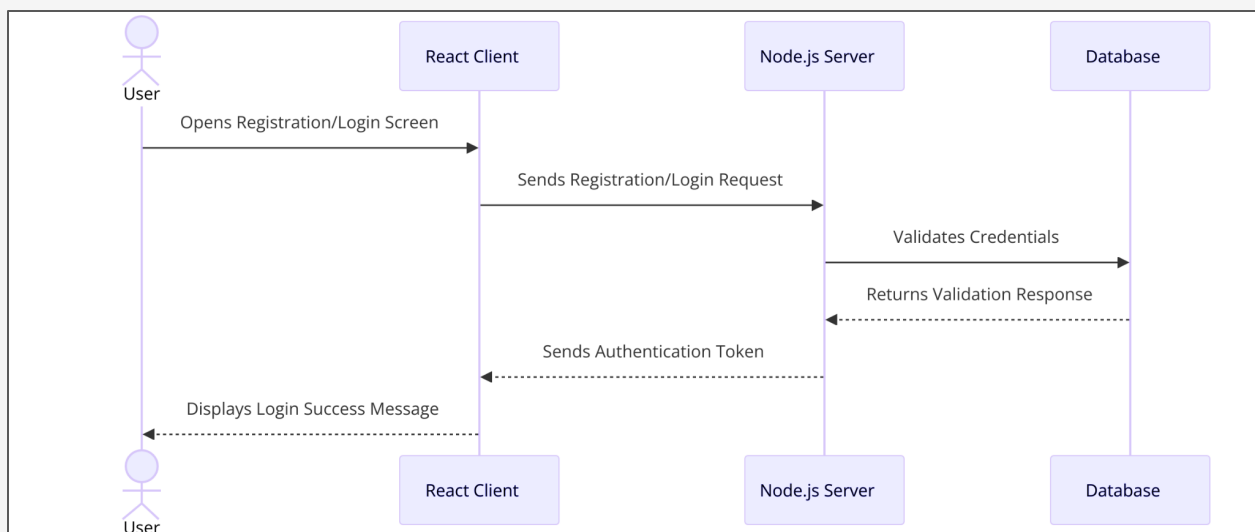

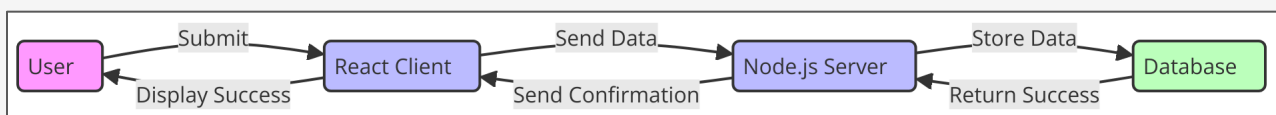
